

ARTICLES OF INCORPORATION  
OF

I, the undersigned natural person of the age of eighteen years or more acting as Incorporator of a corporation, under the Business Corporation Act (D.C. Code, 1981 Edition, Title 29 Chapter 2) adopt the following Articles of Incorporation:

- FIRST:** The name of the corporation is Aviation Management Service, Inc.
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose for which the Corporation is organized is to carry out consulting and management services within the airlines and aircraft industries, and all ancillary services connected herewith both within and without the District of Columbia.




